



VENDOR RULES & GUIDELINES

*There are 10'x10' booth spaces available.
Spaces can be increased upon request and availability.
Booths are available on a first come first serve basis.
Security will be provided on the Fairgrounds.*

1. Applications will be reviewed upon receipt and approved by the Harrison County Fair Association Board of Supervisors.
2. The vendor fees are as follows:
 - A. Arts & Crafts (Handmade Items) - \$200.00
 - B. Direct Sales - \$350.00
 - C. Non-Profit Organizations - \$25.00
 - Must be a 501(C)3
 - Free for 5 Days (Limited Availability)
 - D. Fair Themed Educational Demonstration
 - Free for 5 Days (Limited Availability)
 - If vendor would also like to sell goods, a fee of \$100.00 will be charged.

DATES AND PROCEDURES OF FAIR, SEPTEMBER 6-10, 2017

1. All exhibitors must be completely set up and vehicles moved off grounds 1 hour before fair opening. Vehicles are not permitted on fair grounds during fair operating hours. If you need to bring in or remove merchandise during the fair, then it will need to be done with a wagon or hand dolly. Anything else will need to be approved by the Harrison County Fair Association.
2. Sales tax will be collected at the end of the Fair. Please price your items to include tax.
3. All exhibitors must make their own provisions for shade or rain.
4. This Fair will be juried. Rain or shine. No refunds.
